- 5 MCAC Gordon Bennett Show & Shine, Millennium Court Arts Centre, Alan Phelan, the sponsors & their officers, agents, & employees will not be responsible for any damage, sustained to the entrant's vehicle or car audio equipment whilst judging is in progress.
- 6 Entrants will be responsible for their own car audio equipment. The event organisers request that all entrants either remove the detachable face or removable head units & keep their vehicle secured if they will be away from their cars at any time.
- 7 The event organisers will provide the maximum amount of Security for the event, but they seek the co-operation of every entrant to ensure that the event runs smoothly.
- 8 Please follow the Judge's instructions, Security personnel's advice & Marshall's directions.
- 9 Once parked in the allocated judging area, the entrants are requested not to start up or move vehicles unless instructed to do so by an Official.
- 10 The judging is based on Installation and not Sound Quality.
- 11 There will be custom designed trophies for the winners and car stickers for all participants.
- 12 The Event is strictly limited to the time 2:00pm - 5:00pm - participants will only be allowed into the staging area from 1:00pm.
